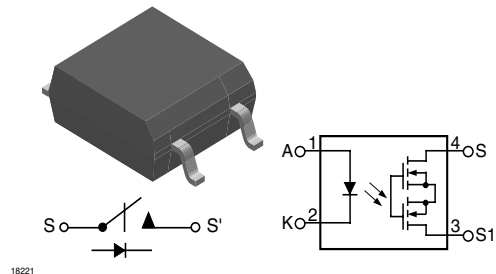

### Description

The LH1546AEF (4 Pin SOP) is robust, ideal for tele-com and ground fault applications. It is a SPST normally open switch (1 Form A) that replaces electromechanical relays in many applications. It is constructed using a GaAs LED for actuation control and an integrated monolithic die for the switch output. The die, fabricated in a high-voltage dielectrically isolated BCDMOS technology, is comprised of a photodiode array, switch control circuitry and MOSFET switches. In addition, it employs current-limiting circuitry which meets FCC 68.302 and other regulatory voltage surge requirements when overvoltage protection is provided.

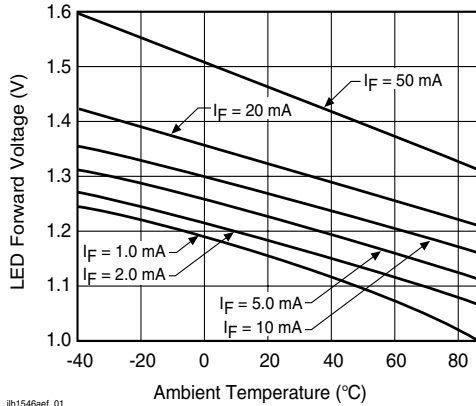


Fig. 1 LED Voltage vs. Temperature

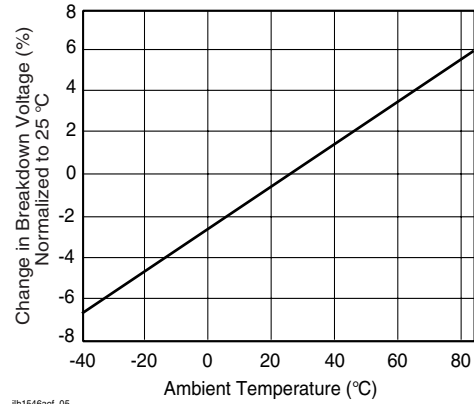


Fig. 4 Switch Breakdown Voltage vs. Temperature

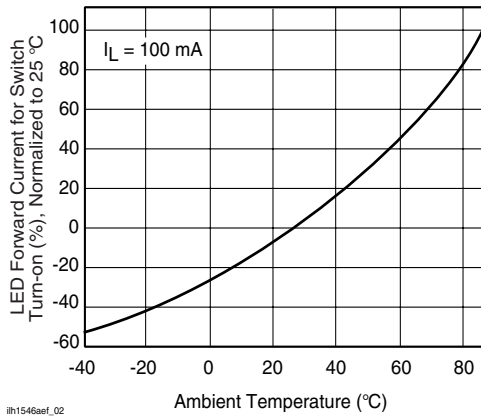


Fig. 2 LED Current for Switch Turn-on vs. Temperature

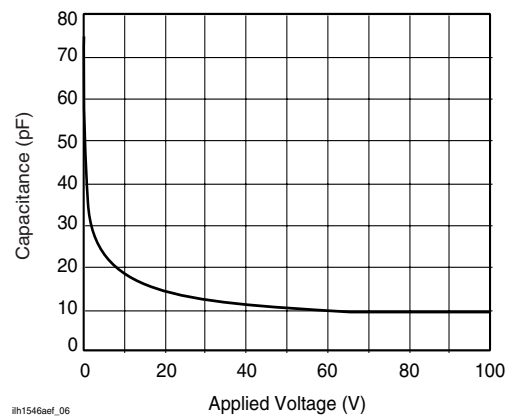


Fig. 5 Switch Capacitance vs. Applied Voltage

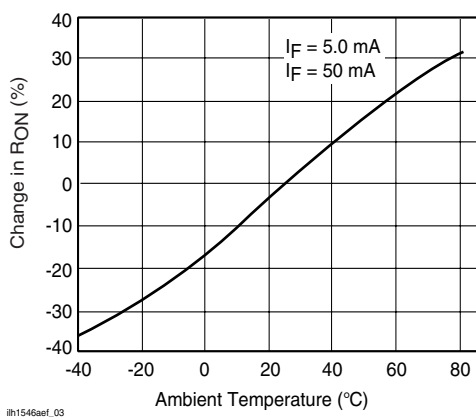


Fig. 3 ON-Resistance vs. Temperature

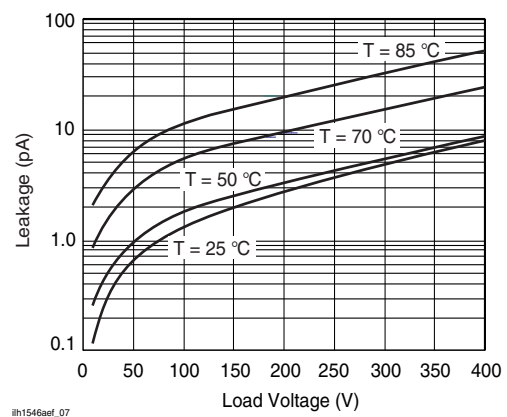


Fig. 6 Leakage Current vs. Applied Voltage

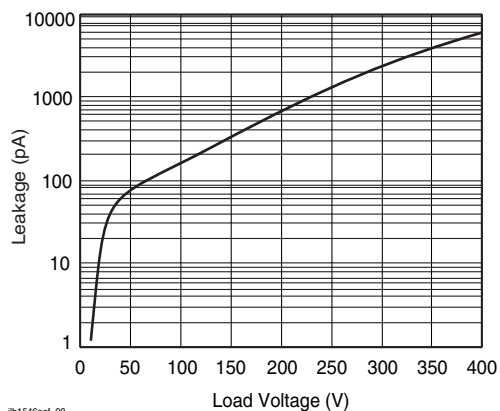


Fig. 7 Leakage Current vs. Applied Voltage

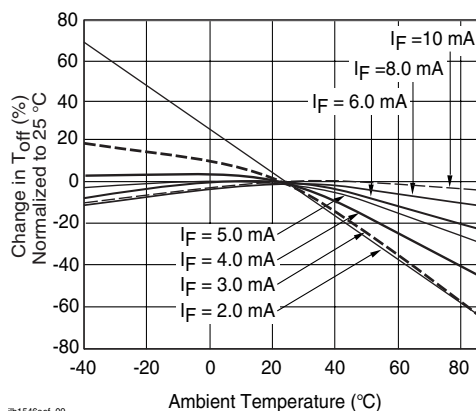


Fig. 8 Turn-off Time vs. Temperature

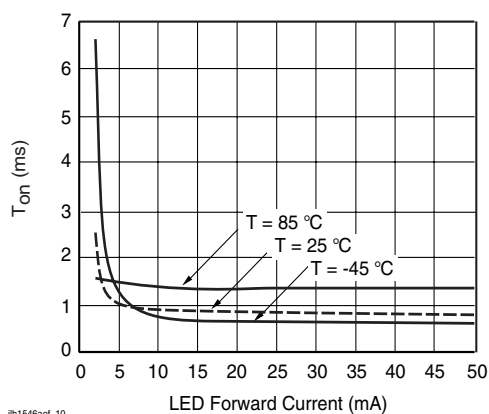
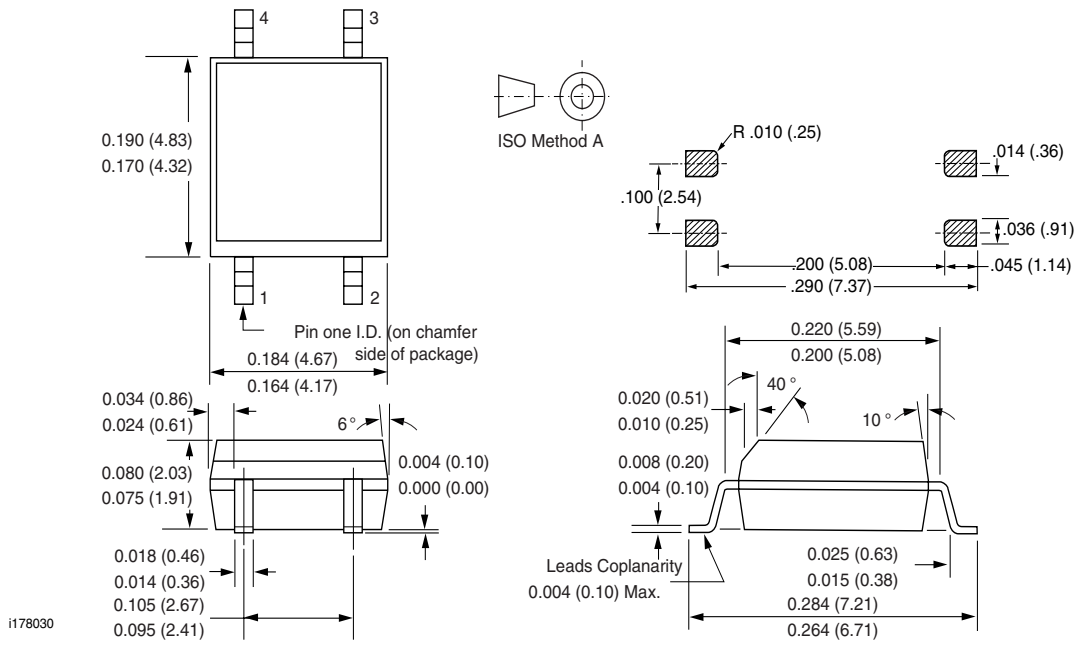


Fig. 9 Turn-on Time vs. LED Current
