Description

Clare and IXYS have combined to bring OptoMOS[®] technology, reliability, and compact size to a new family of high-power, solid state relays. As part of that family, the CPC1916 is a single-pole, normally open (1-Form-A) solid state relay. The CPC1916 employs optically coupled MOSFET technology to provide 2500V_{rms} of input to output isolation. The efficient MOSFET switches and photovoltaic die use Clare's patented OptoMOS architecture, while the output is controlled by a highly efficient GaAIAs infrared LED. The combination of low on-resistance and high load-current handling capabilities makes the relay suitable for a variety of high-performance switching applications.





Board Wash


Clare recommends the use of no-clean flux formulations. However, board washing to remove flux residue is acceptable. Since Clare employs the use of silicone coating as an optical waveguide in many of its optically isolated products, the use of a short drying bake could be necessary if a wash is used after solder reflow processes. Chlorine- or Fluorine-based solvents or fluxes should not be used. Cleaning methods that employ ultrasonic energy should not be used.
