


Output Characteristics




On-Resistance vs. Drain Current






Transfer Characteristics



Capacitance




On-Resistance vs. Junction Temperature











On-Resistance vs. Gate-to-Source Voltage



Threshold Voltage




Single Pulse Power, Junction-to-Ambient







Current Derating*










